

# PRIVACY POLICY

We are generally subject to Swiss data protection legislation (Data Protection Act/DSG and Data Protection Ordinance/VDSG).

To the extent applicable, we shall, however, also adhere to the EU General Data Protection Regulation (GDPR) of 27 April 2016, which also brings about certain external effects for companies and institutions in the non-EU country of Switzerland. With respect to the upcoming revision of the Swiss Data Protection Act (DSG), which will in part draw on the EU regulations, we will inform you below in accordance with Art. 13 of GDPR regarding the collection and processing of personal data by us.

#### 1. Introduction

## 2. Types of personal data we process

We collect and process voluntary personal data that you provide by sending us an email, applying for a job, accepting an offer of employment, completing an online form or enrolling yourself or your children in our school or related service (e.g musical event). The personal data we process takes different forms and includes:

- names, addresses, telephone numbers, e-mail addresses and other contact details
- information pertaining to students enrolled at Copperfield contact details, academic progress such as grades, end of term reports, examination results, information related to a student's health



- images, audio and video recordings.
- 3. Collecting, handling and sharing personal data

All personal data collection and analysis is done in compliance with both the applicable Swiss and European data protection laws and the corresponding data are treated confidentially.

We collect most of the personal data we process directly from the individual concerned (or in the case of students, from their parents).

- Personal data held by us is processed by appropriate members of staff for the purposes for which the data was provided. We take appropriate technical and organisational steps to ensure the security of personal data about individuals.
- If an individual completes a form on our website, he/she has the option to give consent to receive generic information from the school. This information is sent to our website-building platform and email marketing platform and is targeted relevant to their interests. For example, information about application

procedures, courses offered and newsletters.

- We will only share personal data with affiliates for the purposes of conducting the activities and business of the school and provision of related services. Such third parties process data exclusively on the basis of our order and may not perform any data processing, which does not occur in connection with this privacy statement, in particular the processing of personal data for its own purposes.
- 4. Purposes for which we process personal data

We process personal data to support the School's operations for the School Year and in particular for:

- Prospective families & educational partners seeking further information regarding programmes offered at Copperfield;
- The admission of students to the School Year;
- The provision of education to students timetables; monitoring student progress, end of term reports;
- The promotion of the school through its own websites, brochures and other publications and communications (including through our social media channels)



- Maintaining relationships with Copperfield alumni and the wider school community by communicating with the body of current and former students and/or their parents/ guardians and organising events.
